Your Executive, Chairpersons, and Zone Reps achieved much in 2016/17.

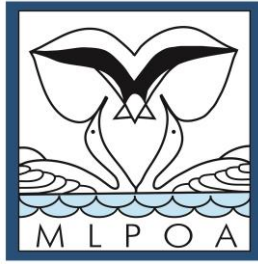

2016 ANNUAL GENERAL MEETING

Minutes

The Annual General Meeting of the Moira Lake Property Owners Association was held at the Madoc Public Library on August 13, 2016 at 10:00 AM.

The meeting was called to order by president, Joe Kaehler, with 40 members and guests in attendance. A motion to adopt the agenda was duly moved, seconded and carried.

Minutes of the 2015 annual meeting were accepted as circulated.

President Joe Kaehler brought the attendees up to date on the activities of the Association during the last year.

Treasurer Chuck Noble presented the 2017 budget which was adopted as proposed.

The Moira Memories Book Project has been well received, with over 300 books sold to date. The Association's \$10.00 subsidy for the first 150 books was filled within days of the book's release.

Chuck Noble reported on the Weed Harvesting Program which is being carried out as per last year, with a small increase in fees for private shoreline harvesting. Harvesting in the for the many common areas such as the inlet and outlet, Deer Creek, the culvert under Highway #62, etc., were also discussed.

Eric Sandford, Centre Hastings Council representative and Liaison on the MLPOA board, brought members up to date on Lake-related activities. Most notably, the Municipality's Fund Matching Program has been reinstated.

Kevin McLaughlin acknowledged the extensive work conducted by Councillor Sandford in reinstating the Program. Kevin then reviewed the process the Lake lanes/roads must follow in order to qualify for the Program. He confirmed that the Program applies to materials only, and that any costs for labour are not covered. He urged Program participants to get the work done as soon as possible (if not already done), and to submit receipts, for materials only, to the Private Roads Committee by no later than Labour Day Monday.

Gordon Pitts, our guest speaker, talked about his book, "Moira Memories - The Life and Times of a Lake". He discussed some of the interesting stories of life around Moira Lake from the last century. Gordon's family have lived on Moira Lake for 140 years. He also enjoys cottage life at his cottage at Pitts Landing. Copies of his book are still available. Gordon was thanked by President Joe Kaehler, and he was presented with a gift from the Association.

This was not an election year, and all existing members of the executive have agreed to serve for the coming year.

Andy Sherwin discussed the Association's website. The site has experienced a year-over-year increase in site visits. The idea of 'selling' space on the website was briefly discussed. That matter will require some research as to the costs for interested parties, and decisions will need to be made as to where on the site any advertising might be permitted.

Meeting was adjourned at 11:30. Next year's AGM will be at the same location on August 12, 2017.

Lake Steward Report – Chuck Noble



Flood Status

On May 4th, Quinte Conservation Authority issued a flood warning for parts of the Moira River Watershed Area due to a week of extremely heavy rain. At the time of writing this Newsletter, there were no well warnings in effect for our area. All of this information and more is available online at: www.quinteconservation.ca

Water Condition & Testing

Testing in the Lake is conducted by several government and quasigovernment bodies throughout the year. Early in the spring and late in the fall, the municipal sewage lagoons are discharged into Deer Creek and through the Lake. This activity is closely monitored, and the test results show that the levels of contaminants in the discharge are very low and way below the permitted safe levels.

The Ministry of Health and Quinte Conservation Authority test the water in the Lake at several different sites, including the public beach, on a weekly basis, and throughout the summer months. This is to ensure that the water quality is safe and suitable for swimming. If a problem should ever occur, an email blast will be sent out immediately to all members. In addition, the occurrence will be posted on our MLPOA website and at all the public beaches.

Broad-Scale Fish Monitoring Program

In 2008, the Ministry of Natural Resource and Forestry (MNFR) created a monitoring program to ensure that the fish life in Ontario's inland lakes is healthy, and that supplies are not being depleted.

In 2016, the MNFR tested Moira Lake to determine the health and populations of its fish life. The results show the fish are healthy, and no sufficient change in the populations has occurred when compared to the previous study done 5 years ago.

Ice Fishing Derby

On February 18, 2017 the MLPOA and the Madoc Lions Club co-sponsored the annual Moira Lake Ice Fishing Derby. Over 300 tickets were sold and in total, \$3,660.00 was raised in support of the Accessibility Playground Equipment Project for the Centre Hastings Park.

Congratulations also to the winner of the 50/50 draw, and to all the winners of the numerous prize draws that were held throughout the day.

Plans are already underway for the 2018 Fishing Derby which will be held on Saturday, February 20, 2018. Be sure to keep that date open, and join us for a great day of fun. How to obtain tickets and all the other details will be posted on our website around year's end.

Buoys

The buoys will be put out on the Lake as soon possible once the water level has dropped sufficiently enough so that the rocks and shoals can be properly identified.

Boaters are once again reminded that buoys are placed on a “**best-efforts**” basis by the MLPOA as a guide to known hazards. However, it is the responsibility of boaters to be aware that there may be unmarked rocks or shoals in the Lake, and to govern themselves accordingly.

Fishing Season

The season for Walleye (Pickerel) and Pike starts on the 2nd Saturday in May. Walleye regulations include a slot size limit. Walleye legally kept must be between 40 and 50 centimeters (15.7 to 19.7 inches).

Muskie season starts on the 1st Saturday in June, and to be kept, they must be greater than 102 centimeters (40 inches).

Bass season (Largemouth and Smallmouth) starts on the 3rd Saturday in June.

REMEMBER - IT IS ILLEGAL TO ATTEMPT TO CATCH FISH FOR WHICH THE SEASON IS CLOSED, EVEN IF YOU ARE PLANNING ON A LIVE RELEASE.

Weed Harvesting

Over 55 private shoreline cuts, combined with all the municipal cuts, were completed on schedule in 2016. The municipality areas include the river inlet and outlet, the Deer Creek inlet, the culvert running under Highway # 62 between Upper and Lower Lake, and the public swimming area at the boat launch. These areas are cut to help increase water flow through the Lake which, in turn, improves water quality.

The program for private shoreline cutting will be offered again in 2017. The first round of cuts is scheduled to start in mid-July. Anyone interested in having their private area harvested will find the application form in this Newsletter. Please complete all of the information, and follow all instructions with respect to marking your property.

The idea behind the harvesting is to allow people to clear areas for recreational swimming and for getting boats out into deeper water without destroying the natural habitat of the aquatic life. Harvesting of private areas must not exceed 100 square yards (about 30' x 30').

The number of properties that we service yearly has been steadily growing, and we have received some very positive feedback from these owners regarding the vast improvement in their swimming areas.

The fees for 2017 are: single cut - \$115, two cuts - \$215.00, three cuts - \$315.00. Fees must be paid in full and in advance. In order to ensure your property is scheduled to be cut, your payment should be received by the Municipality no later than **July 1, 2017**. Make your cheque payable to "The Municipality of Centre Hastings – Weed Harvesting".

It is important that you physically identify your property with the **Lane Name and 911 #** so that it is clear and easily visible from the Lake. This is to help the harvester operator find the correct properties that are scheduled to be cut. This can be accomplished with either a permanent or temporary sign at the water's edge or on your dock. If you have any submerged water intake lines or pumps, please be sure to mark their location with a float to avoid having them damaged by the harvester.

Have a fantastic season, and enjoy beautiful Moira Lake throughout the year!

About the Book:

The book is called “Moira Memories – The Life and Times of a Lake” and that is precisely what it contains – colourful yarns from the lake, spanning the years from First Nations people who were the original inhabitants through the cottage era to the modern-day residents. This is very personal history about the people who made Moira a special place, from Henry Mitchell, the wise woodsman from the North Shore, to Biff Symon, the obsessive mine builder, and John Weir Foote, the Second World War hero. Full of pictures though the ages.

About the Author:

Gordon Pitts is a journalist and author and is currently a business writer in residence at the DeGroot School of Business at McMaster University in Hamilton. He has been a writer and editor for Canadian newspapers for close to four decades, in addition to writing six books. One of his books, Stampede!, won Canada’s national business book award. Pitts is retired after 21 years at the Globe and Mail, most recently as a senior writer in the Report on Business. He was raised at Pitts Landing on Moira Lake and still has a cottage there.

Centre Hastings Skate Park

In last year’s newsletter, we informed you that the Skate Park fails to meet the current minimum standards for accessibility. Mr. Charles Gordon, the Park’s Ambassador, has done an amazing job in raising several thousands of dollars over the past year, and many park improvements are well underway. For those who wish to help, you may still make a personal donation to this project. Receipts for tax purposes will be issued on all amounts \$20.00 and over. As necessary, please make such a request, and include your mailing address.

Madoc Wastewater Lagoon System

In the spring of 2015, your board of directors attended an in-depth tour of the Madoc Wastewater Lagoon System. It is managed by the Ontario Clean Water Agency (OCWA). To our members who may not be aware, the lagoon system is discharged in the spring and fall of each year. It flows into the south section of Deer Creek before entering the upper lake. We were very impressed with this tour, especially when

the officials informed us that during the discharges, the quality of the water in the south of Deer Creek tested better than the water in Deer Creek north of the discharge area. We commend the officials at OCWA, and congratulate them on the results.

Each year, the OCWA issues a detailed report to the Municipality of Centre Hastings, summarizing their findings. Though very technical in nature, their 2015 report can be found on the Municipality's web site at:

Road Gravel Fund-Matching Program – 2017

We are pleased to advise that all Zones participated in last year's Gravel Fund-Matching Program. Thanks to Councilor Eric Sandford, the Program was reinstated by the Municipality in 2016 with a fund total of \$5,000.00. For 2017, the fund total has increased to \$5,500.00. In addition for 2017, the funds will apply to other materials, such as reground asphalt, not just gravel.

Important to note: The cost of labour is not covered under this Program. For example, the cost of gravel would apply, but the labour cost to spread the gravel would not apply.

To participate in the Program this year, Zones are reminded that their receipts (for materials only – not labour), must be received by to the MLPOA Private Roads Committee c/o Kevin McLaughlin, PO Box 675 Madoc On K0K 2K0, **no later than Labour Day Monday.**

Garbage Bins and Recycling Stations

The directives for recycling are included in this Newsletter. They show what to recycle and what not to recycle.

Our members again have requested that we again remind lake property owners and their guests that **all re-cycling is to be properly sorted, placed in the blue bins and not left on the ground next to the bins. The garbage bins are for clear bags only, containing household garbage only. The ground around this bins is not to be used as a drop for other types of disposals.** Simply stated, if the disposal does not belong in either the recycling or garbage bins, it is to be taken to the landfill site (see below).

We are also reminded that the garbage and recycling stations around the Lake are provided by the Municipality as a convenience for those of us who own property on the Lake. Most lakes in Ontario do not enjoy this convenience. We need to ensure these stations are being properly used. Misuse only causes unnecessary time and expense, and we run the risk of losing the stations altogether.

These bins are for the exclusive use by lake property owners and their guests. If you see someone who should not be using the bins, please record the vehicle license number, the time and date, and report the incident to the Municipality at 613-473-4030.

Landfill Site

The Municipality of Centre Hastings Landfill Site and recycling station is located at 106968 Highway #7, east of the intersection of Highways #7 and #62. The phone number is 613-473-4581.

The hours of operation are Mondays and Wednesdays from 8:00 AM – 12:00 (Noon); and Saturdays from 8:00 AM – 4:00 PM.

Summary of Centre Hastings Fire By-law 2006-20

During the period from April 1st to October 31st no fire for the burning of grass, rubbish, wood or other combustible material shall be permitted outdoors between the hours of 7:00 am – 7:00 pm, except for the following:

- Fire for cooking or warmth
- A small fire no more than 1x1 meter attended at all times by an adult
- A fire in a metal container covered by a metal mesh ¼ inch in size

Please note:

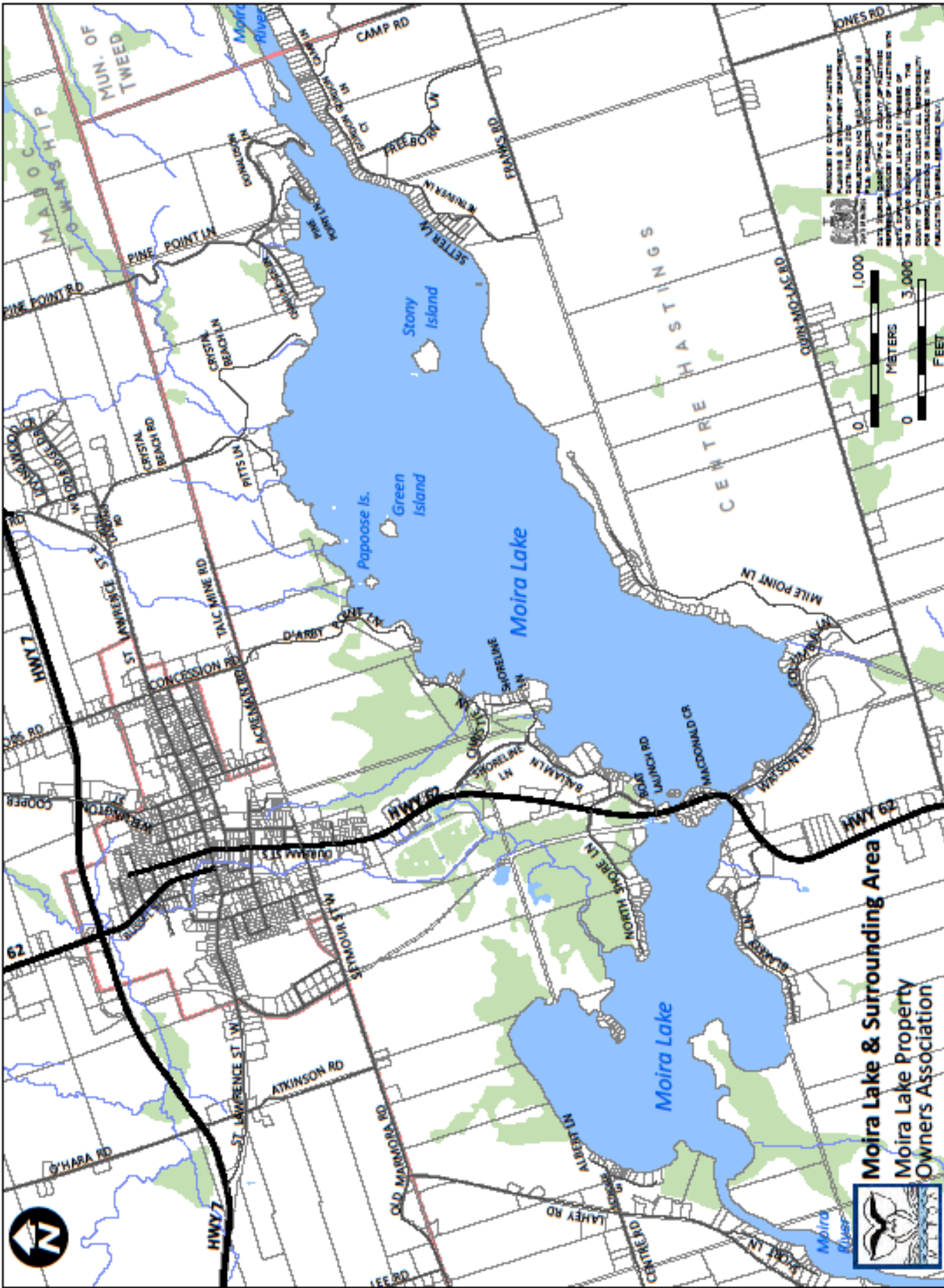
- Between October 31st and April 1st of any calendar year, persons who permit any fires to burn out of control shall be responsible for the cost to extinguish the fires.
- If the need arises for the Fire Department to use the services of the MNR water bombers, all watercraft are to be docked.
- Remember to check all your smoke detectors when you return for the summer.

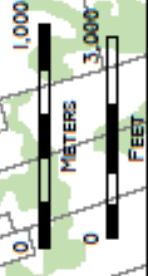

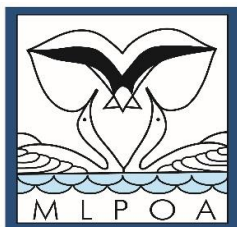
