

## Greetings from the President

On a more serious note, it has been a very tough year for our neighbours who experienced flooding of their homes and cottages. Help may be on the way from the Ontario Disaster Relief Assistance Program for full-time residents, but cottagers are on their own. ODRAP rules only apply to living essentials, which does not include secondary properties.

Having said that, there have been many positives in and around the lake this past year, including the 10<sup>th</sup> Anniversary of the Regatta, a wildly successful golf tournament (thanks to Marty Webster and his team of helpers), another great ice fishing derby on the Family Day Weekend in February (thanks to Tadum Neuman and Brad McNevin) and a successful weekend of snowmobile ice drag races (thanks to the Centre Hastings Snowmobile Club – Madoc).

2014 promises to be an interesting year as well. As always there will be lots to do in and around Moira Lake and I encourage you to explore the many local attractions, such as the O'Hara Mill Homestead, while you are in the area.

Improvements continue at the Moira Lake boat launch. The new entrance was completed late in the fall and hydro is currently being added to the washrooms/change rooms.

Starting in May the Madoc Village Classic Cruise Nights resume in downtown Madoc in front of the Medical Centre. Join us downtown on Wednesdays from 5PM – 8PM on May 14 & 28, June 11 & 25, July 9 & 23, August 6 & 20, and September 3. The final cruise of the season will be at the Madoc Fall Fair, September 21. All net proceeds go to local charities.

In July the Centre Hastings Non-Motorized Regatta will again provide a fun-filled day of family activity. There is currently a proposal on the table for a commercial para-sailing company to attend the Regatta for any adventurous souls who would like to para-sail (for a fee) on Moira Lake. More details are in the Regatta flyer.

Our Golf Tournament returns in August 2014 and you will find more details elsewhere in this newsletter. Last year we were able to donate over \$3,000 to Minor Hockey in the local community, including over \$1,000 to the local Bruce Lee House League, thereby enabling the fees to remain affordable for kids who might not otherwise be able to play.

On October 27<sup>th</sup> 2014 there will be an election for municipal governments across Ontario. The Association is taking the position that ALL of our Members should inform themselves and vote in the Centre Hastings election whether you live year-round at the lake or not. Voting by mail is available to Centre Hastings property owners. We also encourage Members to be well informed about the candidate choices. To that end the Association will be asking all candidates for municipal council positions in Centre Hastings to submit their platform information to us, including answering some questions on issues of specific interest to lakeside property owners. As these documents are received they will be posted to the MLPOA web site for the benefit of informing our Members. Please be sure that your voice is heard in the 2014 municipal elections.

Last, but not least, I want to thank Joe Kaehler, Grant Ketcheson and Chuck Noble for their support on the MLPOA Executive since our August 2013 election. Our Board Members and Zone Representatives as well as other volunteers do an outstanding job so that we can hopefully provide relevant and useful services to you, our Members.

## **2013 ANNUAL GENERAL MEETING**Minutes

Date: Saturday August 10, 2013

Time: 9:00 am

Location: Madoc Public Library (Basement)

Meeting called to order at 9:00 AM by President Bob Hadley.

A presentation was given by Mr. Keith Taylor, Source Water Protection Manager of Quinte Conservation Authority, on the Source Water Protection Program as well as other Quinte Conservation programs and services. Emphasis was placed on proper monitoring and testing of wells and septic systems to ensure that they do not pose a hazard to the health of our drinking water systems. President Bob also noted that the Association has been collaborating with Quinte Conservation on activities that the Association might undertake in terms of water quality monitoring as a benefit to lake residents, plus the lakeside resident information packages which were distributed to all Moira Lake residents this spring and summer.

Deputy Reeve Tom Simpson brought greetings and an update on municipality business and issues to the meeting. Tom summarized the many positive activities and events going on in the community. In discussion of the road gravel program the Deputy Reeve, noting that he was speaking on his own behalf and not on behalf of Council, suggested that a road maintenance program in the order of \$20,000 was not out of the question if the Municipality and the Association could work out details for a 5 year

and 10 year road maintenance plan for lake access roads.

Tom Simpson switched hats to present an update as the Chair of the Boat Launch Revitalization Project. After summarizing the progress made to date in the current phase (new launch ramp, improved pier and extended docking, new washrooms and change rooms, expanded parking area, etc.) Tom noted that future phases to stopup the current entry from Highway 62 will follow shortly and that additional funding is being sought to improve accessibility, signage and so forth. At the end of Tom's update President Bob presented him with a cheque for \$500, representing the 4<sup>th</sup> of 5 contributions of \$500/year approved by the MLPOA membership in 2010.

## **MLPOA Business Meeting**

In the absence of Secretary Grant Ketcheson President Bob asked Members whether they wished to have the minutes of the 2012 AGM read or preferred to adopt them as posted on the Association website. The meeting was unanimous in not wanting the minutes read. It was moved by Joe Kaehler, seconded by Chuck Noble, and carried, "that the minutes of the 2012 AGM be approved as posted".

Joe Kaehler presented the financial report as of December 31, 2012 (as reported in the 2013 newsletter) and the current financial status of the Association on behalf of Treasurer Dana Gawley who was unavailable for the meeting. It was moved by Joe Kaehler and seconded by Jim Bakker and carried "to continue the membership fee at \$20 for 2014". Following this Joe presented the 2014 proposed budget as printed on the meeting agenda. It was moved by Joe Kaehler, seconded by Kathy Quart and carried "to accept the 2014 budget as presented".

Bob introduced Chuck Noble who took over the Lake Steward role following the resignation of Jim Beatty in the Fall of 2012. Chuck updated Members on the status of the weed harvester, as well as discussing the idea of conducting more water testing to assure lakeside property owners that the quality of the lake water is being monitored. Chuck asked that his contact

information be posted on the website for those who may wish to contact him regarding the weed harvesting program.

In response to a question from the floor Chuck indicated that if there are new areas of weeds that are preventing access to the lake for some residents we could consider adding those areas to the "public areas" permit request going to the Ministry of Natural Resources for next year.

The Operations Officer Report was given by Bob Hadley as a combination President/Operations update. 2012/13 has been a very busy year. The Executive conducted a survey of Members due to concerns about lack of volunteer support and people standing for office. The responses were mostly supportive of the MLPOA continuing and focusing on its "core" mandate, i.e. road gravel, water quality, buoys, etc.

More communications were sent to Members using the "e-mail blast" technology of our website software. Key topics were the survey, road gravel program and the new fire bylaw. It was also noted that Bob Hadley and Joe Kaehler met with the County Warden and county planning executives regarding unfair taxation relative to services provided (Limited Service Residential zone), and that investigations in this direction will continue.

The 2 public meetings regarding the Open Air Burning Bylaw have been held and the backlash against the proposed bylaw was significant. The MLPOA will continue to work toward a reasonable bylaw that respects the tradition of the cottage campfire while providing reasonable safety measures and prevention of burning of toxic products.

In the coming year the bylaws of the MLPOA will need to be rewritten in order to comply with the requirements of the new Not for Profit Corporations Act.

Finally, it was noted that 2014 is a Municipal Election year and that lakeside property owners should be encouraged to make themselves aware of the issues going into the election and to vote. Special note was made that seasonal residents should exercise their right to vote in Centre Hastings via their mail-in ballot and to have a say in the Council that governs their summer residence.

## Other Committee Reports

Kevin McLaughlin noted that there was not much to report on the Private Roads Committee given the lack of funding in 2013 for the program. Andy Sherman reported on behalf of the Website Committee that the Wild Apricot software system that we are using is a useful tool and is more than just a website. The program also includes a membership database component and allows the Association to contact its members through "e-mail blasts" to keep them informed of current issues. President Bob noted that on August 24<sup>th</sup> the charity golf tournament would be back in support of minor hockey. Marty Webster is coordinating the tourney this year and is hoping to have a great event.

Election of Directors – 2014-2015 President Bob relinquished the Chair to Vice-President Don Berry. Don noted that he and Treasurer Dana Gawley did not want to let their names stand for office in 2014-15. He further indicated the Bob Hadley and Grant Ketcheson were both willing to allow their names to stand for office and declared them appointed. There was a call for nominations from the floor to fill remaining Director vacancies. Don Berry nominated Joe Kaehler, seconded by Kevin McLaughlin. Joe indicated that he would allow his name to stand and his appointment was carried by the membership. There were no additional nominations after 3 calls and the elections were closed. It was noted, in response to a question from the floor, that if others are interested in joining the Directors afterward they can come forward.

President Bob Hadley adjourned the meeting at 11:35 AM.

## **Special Notes:**

**Note 1** - The Centre Hastings Road Gravel Matching Program is subject to approval in the Municipal budget process. The MLPOA handles administration of the funds, in and out.

Note 2 – The MLPOA has a term deposit of \$5,000 which matures March 28, 2014.

## Lake Steward Report – Chuck Noble

This winter brought far larger than normal amounts of snow fall and because of this lake levels reached the 100 year high water mark with flooding experienced in some areas. A well warning has also been issued for the flooded areas and residents are advised to have their drinking water tested.

**Ice Fishing Derby** - The 5th Annual Moira Lake Ice Fishing Derby was held on the Family Day weekend in February. This event, coordinated by Brad McNevin and Tadum Neuman, drew over 350 registered participants and raised about \$4,400 for the Heart of Hastings Hospice. Once again the MLPOA provided a trophy to the winner of the Largest Fish (Youth Division) category. Congratulations to Dalton Bancroft who won the trophy this year.

Water Testing – Testing in the lake is conducted by several government and quasi-government bodies throughout the year. Early in the spring and late in the fall the municipal sewage lagoons are discharged into Deer Creek and through the lake. This activity is closely monitored and the test results show that the levels of contaminants in the discharge are very low and much below the permitted safe levels. Nevertheless, the MLPOA continues to voice concerns that the nutrient value (nitrogen, phosphorous, etc.) in the discharge does promote weed growth in the lake. The Ministry of Health and Quinte Conservation Authority also test the water in the lake at several sites, including the public beach, throughout the summer months to ensure that the water quality is suitable for swimming etc.

**Buoys** – Boaters are once again reminded that buoys are placed on a "best efforts" basis by the MLPOA as a guide to known hazards. However, it is the responsibility of boaters to be aware that there may be unmarked rocks or shoals in the lake and to govern themselves accordingly.

Fishing Season Reminder – Open Season for Walleye (Pickerel) and Pike starts the 2nd Saturday in May, Muskie starts the 1st Saturday in June and Bass (Largemouth and Smallmouth) starts the 3rd Saturday in June. This was a change in 2013 for bass season, opening one week sooner due to earlier spawning seasons. Walleye regulations now include a slot size limit. All walleye legal kept must be between 40 and 50 centimeters (15.7 to 19.7 inches). REMEMBER - IT IS ILLEGAL TO ATTEMPT TO CATCH FISH FOR WHICH THE SEASON IS CLOSED, EVEN IF YOU ARE PLANNING TO RELEASE THEM.

Weed Harvesting - In 2013 the weed harvester was capsized at the very beginning of the season and by the time it was repaired it had been lost to the lake for the summer. Fortunately no one was injured and the harvester has now been fully repaired and harvesting is scheduled to begin in the "public areas" the 3rd week in July. Those areas designated as the public areas are the Kiwanis Beach (boat launch); the Moira River inlet and outlet, Reynolds Landing, Deer Creek inlet and the culvert under Highway 62 to maintain water flow through the lake and keep the beach area clean for swimmers. This service will continue in 2014 with harvesting of both public and private areas starting after the permitted date of July 1st. For those interested in having their private beach areas harvested an application form is contained in this newsletter for your convenience. Please complete all of the information and ensure that you follow all instructions with respect to marking your property. Harvesting of private areas must not exceed 100 square yards (about 30 x 30 feet). The idea behind this is to allow people to have cleared areas for recreational swimming and for getting boats out into deeper water.

The cost for 2014 remains \$90.00 for a single cut, \$170 for two cuts, or \$250 for three cuts, if paid in advance.

**Payment must be made by July 1<sup>st</sup>.** Please make your cheque payable to "The Municipality of Centre Hastings – Weed Harvesting". Mail your cheque to: The Municipality of Centre Hastings, RR # 5, Madoc, Ontario, K0K 2K0, Attention: Treasurer.

It is **important** that you physically identify the property/area you wish harvested, showing your Lane Name and 911 # **visible from Lakeside**, to allow the harvester operator access to the correct location. This can be accomplished with either a permanent or temporary sign directing the operator to the area you wish harvested. If you have any submerged water intake lines or pumps please mark their location with a float to avoid having them damaged by the harvester.

## **Summary of Centre Hastings Fire By-law 2006-20**

During the period from April 1<sup>st</sup> to October 31<sup>st</sup> no fire for the burning of grass, rubbish, wood or other combustible material shall be permitted outdoors between the hours of 7:00 am – 7:00 pm, except for the following:

- Fire for cooking or warmth
- A small fire no more than 1x1 meter attended at all times by an adult
- A fire in a metal container covered by a metal mesh ¼ inch in size

#### Please note:

- Between October 31<sup>st</sup> and April 1<sup>st</sup> of any calendar year, persons who permit any fires to burn out
  of control shall be responsible for the cost to extinguish the fires.
- If the need arises for the Fire Department to use the services of the MNR water bombers, all watercraft are to be docked.
- Remember to check all your smoke detectors when you return for the summer.

## Road Gravel Program – 2014 – Unfunded again

During the initial meetings for the 2014 budget MLPOA Treasurer Joe Kaehler made a presentation to the Centre Hastings Council asking for reinstatement of the Road Gravel Program for the 2014 road maintenance season. Later, when department heads presented their budgets no allowance was made for the Road Gravel Program as a line item in the budget. During discussion of the Public Works budget for gravel and grading Councillor Kramp-Neuman asked if this included the Road Gravel Program and Councillor Mitz responded that road gravel for private roads was a different matter. That was the entire extent of consideration of the program for 2014 by Council and there will be no program again in 2014.

## **Garbage Bins and Recycling Stations**

Only non-recyclable household waste contained in CLEAR PLASTIC BAGS is to be placed in garbage bins. The recycling stations are for recyclable waste as per directives issued by Quinte Waste Solutions. These directives are available from either your Zone Reps or the Landfill Site. All non-collectable material is NOT to be left at these garbage and recycling stations, but MUST be taken to the landfill site.

#### **Landfill Site**

The Municipality of Centre Hastings Landfill Site and recycling station is located at 106968 Highway #7 East, 4.5km East of the intersection of Highways #7 and #62. Their phone number is 613-473-4581.

**NOTE**: As of May 5, 2014 the **new "year-round" hours** of operation for the Landfill Site are Monday 8:00 AM – 12:00 Noon; Wednesday 8:00 AM – 12:00 Noon and Saturday 8:00 AM – 4:00 PM.

## 6 ways to reduce garbage at the cottage

A childhood trip to the cottage dump was a great adventure—especially if, most of the time, we lived somewhere where garbage simply disappeared in the back of a snorting, rumbling truck. Whether your parents or grandparents were inveterate dump pickers or simply drive-and-drop types, there was always a strange, smelly fascination with those piles of garbage and their attendant populations of gulls, deer and bears.



Nowadays, it's a little harder to quash the guilt that goes with garbage disposal—and with many rural landfills and transfer stations launching mandatory recycling and increased costs for disposal, garbage reduction has become a whole lot more interesting than garbage picking.

Follow our tips for greening your garbage at the cottage.

#### Reuse everything—even disposables

Reader Karen Hatton shared this clever garbage-saving tip with us on Facebook: "Wanted to share our cottage solution for cutting down on the use of too many disposable cups. At the beginning of the weekend everyone takes a cup and doodles their name and a character on their cup. When not in use, cups get hung on a string with a clothespin. This keeps them out of the way and the kids love it!"

If you get plastic disposable dishes, you can wash and reuse them for a weekend, then recycle them when you get home. Ideally, though, don't use disposables at all. If your cottage is short on dishes, hit a garage sale or thrift shop on your way up, and make a game out of stocking your kitchen with the tackiest (cheapest) dishes you can find.

## Plan meals carefully

Even though food is biodegradable, it still takes up space in a landfill, and can create large amounts of greenhouse gases as it decomposes. Plan your meals carefully to avoid food waste and unnecessary leftovers—or make sure you bring plastic containers so you can take those leftovers home with you.

### Bring up as little packaging as possible

If recycling facilities at your cottage are limited, take items out of their packaging before you leave and recycle the wrapping at home. Transport food in reusable containers, rather than throwing boxes and wrappers in the cottage trash. Buy frequently used items in bulk, then bring up only what you need each trip, or keep them in bulk dispensers. And if you have to use bottled water, buy large bottles rather than individual ones.

#### Find eco-friendly crafts

Rather than pre-purchased craft materials, look for ways to incorporate natural items into rainy day activities. Glue dried flowers onto a cereal box to store jewellery, make a model city out of sticks or colour on fallen birch bark. Collect paper that's been printed on one side for cottage sketchbooks or scratch pads. Reuse old paper for score pads.

#### Think about composting

A cottage compost pile can be easy to maintain and can stay wildlife-free if you avoid meat and dairy products and use a sealed container. (One that rotates can make turning your compost—a must to speed up decomposition—easier and a lot less messy.) If you're nervous about attracting bears, a smaller kitchen composter can be a good alternative—or, if you fish at the cottage, look into getting a worm composter.

#### Get the kids involved in tracking your waste

Set a goal for the family—like one less bag of garbage each visit—and involve your kids and guests in helping you meet the goal. A colourful chart and a reward for good behaviour can turn waste-watching into a fun game.


